**Count One**      **Felonious Assault - F2**  
§2903.11(A)(2), 2903.11(D)(1)(a)

**Date of Offense**    On or about March 12, 2024

*Complainant being duly sworn states that Blake W. Clabough, in the City of Celina, Mercer County, Ohio, on or about March 12, 2024, unlawfully*

*did knowingly cause or attempt to cause physical harm to Victim # 1 by means of a deadly weapon or dangerous ordnance, to wit: Glock 19 9mm handgun serial number BZM266.*

*The offense is contrary to the form of the statute in such case made and provided, and against the peace and dignity of the State of Ohio.*

**Specification for Forfeiture of a Weapon - §2941.1417(A)**

Blake W. Clabough is the owner and/or possessor of a Glock 19 9mm handgun serial number BZM266, which was contraband and/or property derived from or through the commission or facilitation of the offense, and/or was an instrumentality the offender used or intended to use in the commission or facilitation of the offense

**Firearm Specification - 3 year - §2941.145(A)**

Blake W. Clabough had a firearm on or about his person or under his control while committing the offense and displayed the firearm, brandished the firearm, indicated that he possessed the firearm, or used it to facilitate the offense

AFFIDAVIT ON COMPLAINT  
(O.R.C. 2935.09)

STATE OF OHIO, MERCER COUNTY, SS:

I, do hereby state that I am employed at the Celina Police Department. The following did occur:

On March 13, 2024 at approximately 10:48 P.M, Officers were dispatched to the 300 Block of West Wayne Street in the City of Celina, within Mercer County, Ohio, for a reported break in to a residence. Dispatch told us that the suspects were leaving in a red in color, Dodge Charger. As I was responding, I saw a red Dodge Charger leaving that area, in an alley. I got behind the vehicle on Wayne Street, beside the Immaculate Conception School and stopped it.

I made contact with the driver. He was identified as a Camron Ofray. He said that he was coming from his house on Murlin Street. I asked him to step out of the vehicle. As we were walking back to the rear of the car, the back seat passenger, identified as Blake Clabough, told me that there was a gun under the passenger's seat. I asked him to step out. He complied and said that the gun was under the seat and it was unloaded without a magazine. He said that the magazine was in the glove box. The front right seat passenger was identified as a William Barga. We had him exit the vehicle also.

I located the firearm under the passenger's seat where Clabough said. It was a "Glock 19" 9mm handgun bearing serial number BZM266. It did not have a magazine or round in the chamber. I also noticed a small amount of blood on the gun so I seized the firearm.

We spoke with both Barga and Clabough. Both said that Victim # 1 allegedly owes Clabough money and/or an electric skateboard, so they went there and when Clabough went in, a fight ensued.

I went to 330 West Wayne Street and spoke with a Victim # 1. I noticed Victim # 1 had two large cuts to his face and head. Victim # 1 told me that there was an issue over a skateboard. He and Clabough set up a meeting at his home. He said that when Clabough got there, he hit him with the handgun. He said that he, and a friend, tried to get the gun away from Clabough, but Clabough took off and ran outside.

After conferring with the County Prosecutor, Clabough was placed under arrest and transported to the Mercer County Adult Detention Facility.
