STATE OF OHIO, MERCER COUNTY, SS:

I, Patrolman Isaac J. Daniel, do hereby state that I am employed at the Celina Police Department. The following did occur:

On May 25, 2025, at approximately 01:06 A.M, Ptl. Powell and I were on patrol when we were behind a silver Chevy truck travelling Northbound on Main Street. As it proceeded Northbound, it was weaving within its own lane of travel. We watched as the vehicle turned into the parking lot of a church, which was closed at the time. It entered from Main Street, then travelled through the parking lot, out onto Meyers Road, now proceeding Westbound. It proceeded to North Main Street, again, and turned Southbound. We continued behind the truck and saw that when it was on Ash Street, it approached the intersection at East Market Street. The truck stopped at the red light, stopping past the stop bar on the roadway. The truck then turned Westbound onto Market Street, failing to signal, prior to 100 feet. The truck proceeded to Market Street and Main Street, stopping at the red traffic light, in the Westbound lane. The driver then turned Southbound onto Main Street, from the Westbound Lane. We initiated a traffic stop.

I made contact with the driver, who was identified as a Shad M. Fields. I informed him of the violations we witnessed. He said that he was trying to get to Union City but was lost. As Fields spoke, I could smell an odor of an alcoholic beverage coming from his breath. I could also smell an odor of burnt marijuana inside the vehicle. I asked Fields to step out perform a series of field sobriety tests. Fields did admit to consuming alcoholic beverages.

I placed Fields under arrest for OVI and while patting him down, I located a "vape" in his right front pocket. Fields admitted that it contained THC and had been using it through the evening. I told Fields if he had any other drugs of abuse, and they were located at the jail, more charges could be added. He said that he didn't have anything else. Fields was transported to the Mercer County Detention Facility.

While being booked in Sgt. Vogel, a corrections officer, located a baggie with a clear white powdery substance, in Fields right shoe. Fields said that the contents were "speed", which is slang for methamphetamine. It appeared to be methamphetamine to me also, and Ptl. Powell, from his training and experience, concurred.
