did knowingly cause or create a substantial risk of physical harm to Victim # 1 by means of strangulation or suffocation.



**AFFIDAVIT ON COMPLAINT**  
**(O.R.C. 2935.09)**

STATE OF OHIO, MERCER COUNTY, SS:

I, Justin Bruns, do hereby state that I am employed at the Celina Police Department. The following did occur:


On July 28, 2025, Mercer County Central Dispatch received a 911 call from 301 Zillah Street, in the City of Celina, Mercer County, Ohio. The call was a male making a report of someone being choked and arguing.

When I arrived, I could hear arguing inside the residence. I located Kami Goldman and her son, Victim # 1. Both parties were separated and spoken to. Victim # 1 said that he came home and found that his room was messed up. He got upset with his 12-year-old brother and started yelling at him. His mother, Kami Goldman got up and started yelling at him. He told Kami that he was leaving and started to go. Kami pushed him against the wall, grabbed him by the throat and dug her fingernails into his throat, and began choking him. He grabbed her by the arm and pushed her off of him. Victim # 1 then said that he called 911 because he knew the violence would not stop.

I also spoke with Goldman. Kami said that she was the one that messed up his room because she was looking for "weed". When Victim # 1 started yelling at his brother, she got involved. Kami did admit to grabbing him by the throat. I did view red marks on Victim # 1's neck.

I was made aware that Goldman had a previous arrest for domestic violence in Celina Municipal Court in 2013.

Goldman was taken into custody and booked into the Mercer County Jail.
