
Complainant being duly sworn states that Keith L. Miller, in Mercer County, Ohio, on or about October 7, 2025, unlawfully

AFFIDAVIT ON COMPLAINT
(O.R.C. 2935.09)

STATE OF OHIO, MERCER COUNTY, SS:

I, Patrolman Zac Nelson, do hereby state that I am employed at the Celina Police Department. The following did occur:

On October 7, 2025, at approximately 4:53 P.M, I observed a white in color, Chevrolet truck travelling Eastbound on West Market Street in the City of Celina, Mercer County, Ohio. I noticed that the front driver and passenger windows displayed a tint that was so dark that I could not see the driver, which is a violation in the State of Ohio. I conducted a traffic stop on the vehicle.

I contacted the driver and identified him as Keith L. Miller, date of birth 08/30/1982. It was a relatively cool evening, but Miller was sweating heavily and appeared abnormally nervous. When he talked, he talked fast, also. I used my tint meter on the driver's side window. It showed that only 2 % light was passing through.

I asked Miller if there was anything in the vehicle that I should know about. He told me no, but he did have a knife. I asked him if I could look, and he agreed. I asked him if I could check his pockets, and he allowed me to. I asked him if I could search his vehicle, and he said that I could.

While searching the truck, I located a small black in color bag, on the passenger seat. Inside the bag I found a baggie of marijuana and a grinder to be used with the marijuana. In the storage compartment of the grinder, I found a white crystal-like residue, that from my training and experience is methamphetamine. I asked Sgt. Balthis to bring a field test kit to my location. While waiting on Sgt. Balthis, I finished searching the vehicle. Nothing else that I found to be illegal, was located. Once Balthis arrived, I conducted a field test on some of the contents in the grinder and it tested positive for methamphetamine.

I transported and incarcerated Miller into the Mercer County Detention Facility.
