Count One **Possession of Cocaine - F5**
§2925.11(A), 2925.11(C)(4)(a)

Date of Offense On or about November 9, 2025

Complainant being duly sworn states that Sharon L. Riley, in Mercer County, Ohio, on or about November 9, 2025, unlawfully

did knowingly obtain, possess, or use a controlled substance or a controlled substance analog and the drug involved was cocaine or a compound, mixture, preparation, or substance containing cocaine.

The offense is contrary to the form of the statute in such case made and provided, and against the peace and dignity of the State of Ohio.

Count Two **Illegal Use or Possession of Drug Paraphernalia - M4**
§2925.14(C)(1), 2925.14(F)(1)

did knowingly use, or possess with purpose to use, drug paraphernalia.

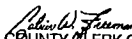

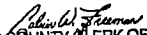

AFFIDAVIT ON COMPLAINT
(O.R.C. 2935.09)

STATE OF OHIO, MERCER COUNTY, SS:

I, Deputy Quintin Thomas, do hereby state that I am employed at the Mercer County Sheriff's Office. The following did occur:

On November 9, 2025 at approximately 4:00 PM, I was on routine patrol in Mercer County, Ohio. I was travelling northbound on U.S. 127 when I observed a white Nissan Altima vehicle with obstructed plates. I initiated my overhead lights to conduct a traffic stop. The vehicle continued travelling about a half mile northbound on U.S. 127 before pulling into Shipyard, which is located at 6301 S. Main Street, Celina, Mercer County, Ohio.

I approached the vehicle and identified the driver, who was the sole occupant, as Sharon Riley. When I asked Sharon for her license, she advised that she was not allowed to be driving on the license she had. I questioned her whether she had anything illegal in the vehicle. Sharon said that she did not.

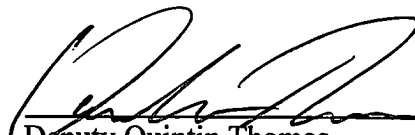
Dispatch informed me that Sharon had a warrant out of Montgomery County for Possession of Cocaine. Deputy Will Fox, who had arrived on scene earlier, had Sharon step out of the vehicle. I placed Sharon in handcuffs, patted her down, and put her in my cruiser.

Deputy Spencer Heintl arrived on scene with his trained narcotics canine. Deputy Heintl's canine performed a free air sniff around the vehicle and alerted and indicated to the odor of narcotics coming from the vehicle.

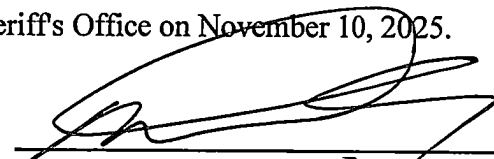
While searching the vehicle, under the driver's seat we located a tube that appeared to contain burnt drug residue. While searching Sharon's purse, we located a small wallet-sized bag that contained smoking pipes, chore boy, as well as a small, cylindrical container that held suspected crack cocaine.

I read Sharon her *Miranda* rights. Sharon advised that the drugs located in the container was, in fact, crack cocaine.

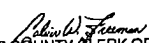
