**AFFIDAVIT ON COMPLAINT**  
**(O.R.C. 2935.09)**

STATE OF OHIO, MERCER COUNTY, SS:

I, Ptl. Isaac Daniel, do hereby state that I am employed at the Celina Police Department. The following did occur:


On May 19, 2025, I saw a white Nissan Cube, travelling Eastbound on East Livingston Street, in the City of Celina, driving at a high rate of speed and failed to stop at the stop sign at Buckeye Street. The vehicle attempted to stop at the last second, but because it was travelling too fast. It skidded, then proceeded into the intersection, without stopping.

I initiated a traffic stop. Det. Poppe was with me. He contacted the driver who was identified as Ryan M. Leach. The passenger was found to be Cindy Maxwell. Maxwell is the registered owner of the vehicle.

By checking through LEADS/NCIC I found that Leach's driving privileges were under suspension and had prior convictions for driving under suspension. Maxwell said that she was aware that Leach did not have driving privileges.

Leach was placed under arrest for the multiple driving under suspensions. When asked if he had anything on him, Leach said that he had "Ice" on him, which I know to be a slang term for methamphetamine. Leach said that he had it in his pants, in his crotch area. We asked him to retrieve it. He reached into the front of his pants and pulled out a small plastic bag and a clear glass pipe, normally used for smoking methamphetamine. The pipe fell out of my hand and broke on the ground. The broken pieces did have residue on them. The clear baggie Leach handed me, contained a crystal-like product that I know from my training and experience, to be methamphetamine.


Leach was transported and incarcerated into the Mercer County Detention Facility.
