AFFIDAVIT ON COMPLAINT (O.R.C. 2935.09)

STATE OF OHIO, MERCER COUNTY, SS:

I, Haiden Stidkam, do hereby state that I am employed at the Mercer County Sheriff's Office. The following did occur:

On February 7, 2025, at approximately 10:56 P.M, I heard radio traffic from Dispatch, in reference to an assault that had taken place earlier in Auglaize County, and the suspect was in a vehicle travelling Westbound on United States Route 33. Deputy Don Sites located the suspected vehicle and conducted a traffic stop, on State Route 127, just off United State Route 33. Victim # 1 responded and arrived at about the same time that I did.

The driver of the vehicle was identified as Richard C. Craw. The passenger in the vehicle was identified as an Angela Stammen. While investigating the previously reported assault, I was speaking with Stammen. She got out of the vehicle and said that she was leaving. Victim # 1 told her that she was not free to leave. As I was speaking with Angela, she became agitated and started to walk away. She was told to stop and that she could not leave. She continued to be angry and again, tried to leave. Victim # 1 warned her that if she tried to leave again, she would be placed into handcuffs and escorted to the back of the cruiser. Stammen dropped a bag she was holding, turned around and put her hands behind her back. Victim # 1 was trying to handcuff Stammen and she started struggling. Deputies got her controlled to the point where she was walked back to a cruiser. While attempting to put her into the back seat, Stammen started kicking Deputies. She kicked Victim # 1 multiple times, connecting with his arms and back. She kicked me once, striking my hand. She was finally contained in the back seat.

Deputy Heinl arrived on scene with his Law Enforcement canine. Heinl had his dog perform a free air sniff around the vehicle. Afterwards, he told us that the dog had alerted.

During the search of the vehicle, I located a large black plastic bag that was inside the trunk. Inside the bag, I found a large amount of jewelry. Inside, with the jewelry, I found a bag with multiple large crystals, that from my training and experience, know to be methamphetamine. Deputy Heinl field tested some of the contents and it did test positive for methamphetamine. The bag was weighed at the office, weighing 9.87 grams.

Stammen was incarcerated for the assault
