





AFFIDAVIT ON COMPLAINT
(O.R.C. 2935.09)

STATE OF OHIO, MERCER COUNTY, SS:

I, Det. Carla Baucher, do hereby state that I am employed at the Mercer County Sheriff's Office. The following did occur:

On July 12, 2025, Deputy Justin Barna was dispatched to a residence located at 4001 Frahm Pike Road, Celina, Mercer County, Ohio on the report of a wallet being stolen out of Victim #1's truck. Victim #1 reported that when he went to leave his residence at approximately 5:45 AM, he noticed that his truck center console was open, and his wallet was missing.

Victim #1 logged into his account with Superior Credit Union and noticed two transactions that he had not authorized. Victim #1 later discovered a third unauthorized transaction at a gas station in Lima, Ohio. Victim #1 contacted Superior Credit Union and canceled the card.

Additional vehicle break-ins were reported to the Mercer County Sheriff's Office and to law enforcement agencies in adjoining counties. Through investigative efforts, law enforcement officers discovered that a credit card stolen from a vehicle was used in an attempted purchase from Wal-Mart on Harding Highway in Lima, Ohio on July 10, 2025. I obtained surveillance footage from that Wal-Mart and identified the suspect as Jordan C. Jackson.

Home surveillance video from a victim in Van Wert County captured the suspect breaking into the victim's car; the suspect on the video likewise was identified as Jordan C. Jackson.

On July 28, 2025, Lieutenant Chris Hamberg and I travelled to Lima, Ohio to conduct surveillance and gather additional information on Jordan C. Jackson. After failing to locate Jackson, we returned to Mercer County. Shortly thereafter, we received a call from Auglaize County officers who also were investigating Jackson. They advised they had located Jackson and the Jeep he was currently driving. Jackson was arrested on an outstanding warrant for Allen County, read his Miranda rights, and agreed to talk with officers.


Jackson admitted that he had been breaking into vehicles for a month or two. He further admitted to stealing items from vehicles in the Celina area. He advised he was familiar with Celina because his child and his child's mother lived in Celina. Jackson further admitted to stopping at convenience stores and gas stations to buy items after the thefts and using stolen credit cards at Wal-Mart in Lima.

Jackson consented to a search his Jeep. Inside the Jeep, officers found some items belonging to victims from Mercer County, including Celina Golf trophies.


While speaking with officers, Jackson also consented to a search of a detached garage at his residence. Inside the garage, officers located a number of stolen items, including a Wells Fargo debit card belonging to Victim #1.
